MEMBERSHIP DESCRIPTIONS

<u>Tennis</u> memberships allow full access to all Club facilities (tennis, swim, gym/fitness and social). <u>Swim/Gym</u> memberships allow full access to all Club facilities except regular tennis play (swim, gym/fitness and social). Limited Tennis is available - private lessons(\$), drill-clinics(\$) and access to ball-machine (\$5/hr).

<u>Single</u> memberships includes 1 person.

<u>Family</u> memberships includes two or more family members (husband and/or wife, dependents). Dependents must be under the age of 18 or (under the age of 22 attending college full time) and share the same residence as the primary member(s).

<u>Young Adult</u> memberships are for persons 33 years of age and under and allows full access to all Club facilities (tennis, swim, gym/fitness and social).

Junior member pricing and court reservations at off peak hours.

All memberships require a 1 year minimum commitment.
